NOTES TO PHYSIC Symptoms	IAN :	Irritation as noted above. Skin sensitization (allergy) may be evidenced by rashes, especially hives. Lung sensitization (e.g., allergy, asthma) may be evidenced by wheezing with shortness of breath and cough.

7. HANDLING AND STORAGE
